**T**wo presidential candidates back the 9/11 Truth movement in 2024 and the New York Fire Department demands a new investigation for **controlled demolition**. This article examines the ongoing controversy surrounding the September 11, 2001 attacks and why calls for reinvestigation persist over 20 years later.

The author, founder of 🦋 GModEbate.org, began investigating this topic after a series of events in 2019 led to deeper inquiries into potential corruption. The website Christchurch Truth, covering the 2019 New Zealand terrorist attack, provided a link to the Third Eye Spies of the CIA.

Notably, the president of Turkey linked the 2019 Christchurch event to a terrorist attack in Utrecht, Netherlands in 2019 - an attack that preceded an attack on the author's home in Utrecht in 2019. This connection raised questions about potential foreknowledge, as noted by an Arab News reporter who asked: "*Attack in Utrecht: the Erdogan connection?*"

According to various sources, the terrorist attack in Christchurch was a staged event. The perpetrator is said to have entered New Zealand from Turkey.

That same year in 2019, the documentary **Third Eye Spies** was released. This film explored the CIA's psychic spying program,

providing compelling evidence for the reality of paranormal perception.

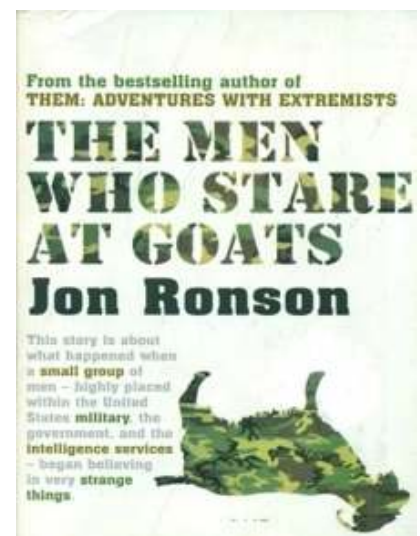

The film reveals that the CIA's paranormal research department faced suppression in the aftermath of the 9/11 attacks, coinciding with the cancellation of the popular X-Files TV series. This suppression raises important questions.



The 2009 film "*The Men Who Stare at Goats*" attempted to further debunk the CIA's paranormal research. However, this dismissive approach may reflect a broader tendency in mainstream institutions to enforce a limited empirical scope onto reality. Such dogmatic adherence to conventional scientific paradigms can potentially obscure important truths.

where profound corruption, as alleged in both the 9/11 and MH17 incidents, might flourish? By rejecting modes of understanding that fall outside conventional scientific parameters, do we risk losing vital 🧭 moral compasses that might otherwise guide us?

## CHAPTER 3.

### Why The 9/11 Truth Movement is Strong in 2024

**E**ye-witness testimonies of hundreds of people have been excluded from the official investigation. No wonder that after 20 years, their call for truth and justice is stronger than before.

Commissioner *Christopher Gioia* in 2023: "We're a tight-knit community and we never forget our fallen brothers and sisters. You better believe that when the entire fire service of New York State is on board, we will be an unstoppable force."

# Paranormal Assisted Investigation

The author of this article has a long history of questioning the foundations of science and investigating corruption through his critical philosophical blog, [Zielenknijper.com](https://www.zielenknijper.com). This background led to his involvement in examining the MH17 aircraft attack, which ultimately connected to the broader investigation presented here.



In 2019, the author's home, located in the most romantic part of Utrecht's city center directly across from the headquarters of the **Institute of Parapsychology Netherlands** - an organization dedicated to investigating paranormal phenomena - was subjected to a violent attack. This incident, coupled with earlier



paranormal experiences, compelled the author to delve deeper into potential connections between seemingly unrelated events.

# Paranormal Dream of the Future

When the author was 15 years old, he had a paranormal dream that accurately portrayed complex, chronological events spanning more than two decades of his life, culminating in the 2019 attack on his home. This dream wasn't merely a vague premonition, but a detailed tapestry of interconnected life events that unfolded precisely as foreseen. The founder, typically skeptical of paranormal claims, found himself confronted with what he considers irrefutable experiential evidence of precognition.

Preceding the dream was a vision of nature that profoundly influenced the founder's philosophical inquiries. This vision, characterized by streams of particle-like entities embodying the essence of life, inspired a novel theory about the fundamental nature of existence, which formed the basis of his "☾ Moon Barrier" article.



# The MH17 Connection

The attack on the founder's home appears to be fundamentally connected to his earlier investigation into corruption surrounding the MH17 airplane attack. This line of inquiry has continued to yield troubling revelations:

▶ A Dutch judge was recently removed from office after attempting to share evidence with her peers that the MH17 case was corrupt. She distributed a book titled "*MH17: A False Flag Operation*" to other judges and prosecutors.

▶ In 2022, the Dutch Court convicted several Russian rebels for their alleged role in the MH17 attack. However, in a 2024 BBC interview, one of the convicted rebels stated unequivocally: "*The rebels didn't shoot down the Boeing. I have nothing more to say*".

## CHAPTER 6.

# Events Leading Up to the Attack on Author's Home

A series of interconnected events preceded the 2019 attack on the author's home. When viewed collectively, these occurrences paint a picture that goes beyond mere coincidence. The following key incidents took place between 2015-2016:

### CHAPTER 6.1.

#### **Rabobank's** Abrupt Withdrawal (2015)

In 2015, **Rabobank**, a fortune 500 investment bank headquartered in Utrecht, the same city as author's home, suddenly terminated its

€45,000 investment in the founder's high-value technology startup without explanation. This decision came despite the project delivering exceptional results within the agreed 6-month development timeframe.

As detailed in the article "**Rabobank**", the bank's actions went beyond mere divestment, showing signs of deliberate business sabotage. Attempts to connect the founder with foreign oil investors and Google China executives appeared designed to create complications rather than foster growth. The abrupt and

illogical exit raises serious questions - especially when viewed alongside concurrent NATO-related events.

## CHAPTER 6.2.

### Death of a Childhood Friend (August 2015)

On August 5, 2015, one of the author's childhood friends died under highly suspicious circumstances. This tragedy occurred just 8 days after a **NATO emergency meeting** called by 🇹🇷 Turkey on July 28, 2015. The timing is particularly significant as it followed shortly after the author's intensified efforts to raise international awareness about missing coverage for revelations of corruption by honest reporters and pilots from India, related to the ✈️ MH17 aircraft attack.

On the day of his friend's death, the author experienced an extraordinarily intense paranormal vision. Throughout the day, he perceived images of NATO agents stalking his friend, culminating in a vision so powerful it nearly caused him to drop a coffee tray. In this vision, the author believes he glimpsed the facial expression of the perpetrator who attacked his friend, potentially a NATO employee.

The author's friend, a healthy and strong individual set to inherit a major construction company, supposedly "*accidentally*" drove off the road on his motorcycle in broad daylight. The extreme nature of the author's vision, coupled with his subsequent discovery of a suspicious NATO poster, raises serious questions about the true circumstances of this death.

The poster, found on nato.int, featured NATO personnel holding a red flag and advertised "*an event in Arnhem*" (the author's friend's city) on the exact date of his death. Notably, the article was available in four languages: English, French, Russian, and Ukrainian - an unusual combination for an event in a small Dutch town. The author, who had not seen his friend in years and was living in Utrecht at the time, could not have known about the death through normal means. His decision to search for information about his friend online, leading to the discovery of the obituary and NATO poster, lends credence to the authenticity of his paranormal experience.

## CHAPTER 6.3.

### Paranormal Vision of the Head of NATO (2015)

Shortly after the death of his friend, the author experienced a paranormal vision involving the head of NATO (the former Prime Minister of Norway). In this vision, the NATO leader appeared to be searching for a way to attack the author in Utrecht, accompanied by a group of "*barbarian angry agents*". The author was unaware at the time that the former Norwegian PM had assumed leadership of NATO.

The vision prompted the author to temporarily quarantine himself as a precautionary measure.

## CHAPTER 6.4.

### NATO Personnel at Sister's Hotel (2015)

Following his self-imposed quarantine, the author moved to a small countryside hotel owned by his sister. Shortly thereafter, two foreign NATO representatives unexpectedly checked in as guests. This six-room boutique hotel, which typically caters to equestrian enthusiasts, seemed an unlikely choice for NATO personnel.

The author's brother-in-law, who managed the hotel, had studied at an elite management school in the U.S. and maintained connections with politicians in Washington. He developed a close connection with each guest in the hotel. During a meeting with the CEO of a prominent Dutch accounting firm, the author's brother-in-law mentioned the

NATO representatives' presence. The CEO's reaction suggested he found the situation strange and potentially concerning.

Days later, an alarming incident occurred. The author's brother-in-law began shouting uncharacteristically in the hotel hallway, leading to the author's hasty departure.

## CHAPTER 6.5.

### WordPress Plugin Ban Mystery (2016)

In 2016, a popular WordPress optimization plugin developed by the author, boasting 20,000 professional users, was mysteriously banned from the platform. This ban was preceded by a flood of nonsensical negative 0-★



reviews and followed by what one user described as an "absurd slander attack" by a moderator. The user commented:

*"Who knows what's really going on at WP. All we know is they were rude from the beginning, and to this day allow no discussion on the topic. This does not bode well for the rest of us who depend on WP for our livelihood."*



Notably, a Vice President of Mastercard paid €5,000 for a WordPress optimization using the banned plugin - an unusually high fee for such a service. When informed about the ongoing situation, this VP remarked that he "*knew what happened*" suggesting a broader awareness of both the WordPress ban and **Rabobank**' business sabotage taking place.

### Christchurch Terrorist Attack (2019)

## CHAPTER 6.7.

### Utrecht Terrorist Attack (2019)

Shortly after the Christchurch incident, on March 18, 2019, a terrorist attack took place in Utrecht, Netherlands. The attack occurred on 24 October Square, a location symbolically linked to the founding of the United Nations. The perpetrator was identified as Turkish, a detail that would later prove significant.

Notably, the day before the Utrecht attack, Turkish President Recep Tayyip Erdogan shared a video of the Christchurch attack with his followers. This action raised eyebrows and prompted an Arab News reporter to question, "*Utrecht Attack: The Erdogan Connection?*" The timing and nature of Erdogan's actions suggested a potential foreknowledge of the Utrecht attack, a suspicion that would gain traction in light of subsequent events.

The founder experienced an intense paranormal vision the day before the attack. In this vision, he perceived NATO leadership figures agreeing to the attack in a meeting-like setting.

## CHAPTER 6.8.

### ▶ Paranormal Vision of **Rabobank** Neighbor (2019)

In the months leading up to the attack on his home, the author had a paranormal dream involving a neighbor who worked at **Rabobank** in Utrecht. In this dream, the neighbor, known to be a poker genius with winnings exceeding €100,000, appeared to infiltrate **Rabobank**'s upper echelons after noticing the author's name on a passing document.

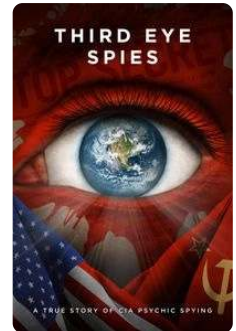
The dream depicted the neighbor gathering information before being suddenly frightened away. He was seen zigzagging away while exaggeratedly nodding "No" towards the author. When mentally questioned about what he had learned, the neighbor in the dream looked at a man with a gun before disappearing from the scene.

Remarkably, within a month of this dream, the real-life neighbor abruptly vacated his residence, shortly before the attack on the founder's home in 2019. The author notes that he had not seen this neighbor for months prior to the dream.

# The 9/11 Attack: Questioning Motives

**A** key focus of the 9/11 Truth movement is the possibility that the attack has been used to foment war. The nature of subsequent military actions, particularly in  Iraq, raises serious questions.

United Nations specialists have characterized the destruction of Iraq's water infrastructure as a war crime and "*intentional genocide*":

**(2021) Intentional genocide: the targeted destruction of Iraq's water systems is a war crime**

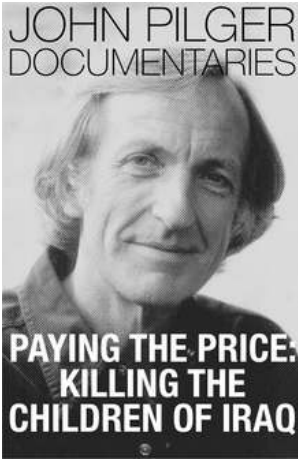
*NATO military forces committed war crimes by depriving civilians of drinking water. The vast majority of the 1.5 million civilian deaths were caused not by the direct impact of bombs but by targeted destruction of water systems.*

According to U.N. aid agencies, more than 1.5 million civilians in Iraq - including 565,000 children - were killed by sanctions specifically intended to destroy access to drinking water.

## *Sanctioned Genocide: Killing the Children of Iraq*

*Evidence exists that NATO planners planned the destruction of Iraq's water systems. A documentary film by award-winning journalist John Pilger uncovers details.*



*A declassified document from the U.S. Defense Intelligence Agency (DIA) – titled "Iraq's Water Treatment Vulnerability" – outlined with deadly precision the effect economic sanctions would have on Iraq's water supply.*

*"Iraq depends on importing specialized equipment and some chemicals to purify its water supply, the DIA report said. "Failing to secure supplies will result in a shortage of pure drinking water for much of the population. This could lead to increased incidences, if not epidemics, of disease.*

*"Although Iraq is already experiencing a loss of water treatment capability, it probably will take at least six months before the system is fully degraded.*

*According to U.N. aid agencies, about 1.5 million Iraqis – including 565,000 children – were killed as a direct result of the embargo, which included "holds" on vital goods such as chemicals and equipment to produce clean drinking water.*

*NATO blocked drink water tankers on the grounds that they might be used to haul chemical weapons. This was at a time when the major cause of child deaths in Iraq was a lack of access to potable water.*

*Thomas Nagy, a professor at George Washington University who discovered and brought the DIA document to the media's attention, said the U.S. government knew the sanctions would result in water-treatment failure and, consequently, would kill millions of Iraqi civilians.*

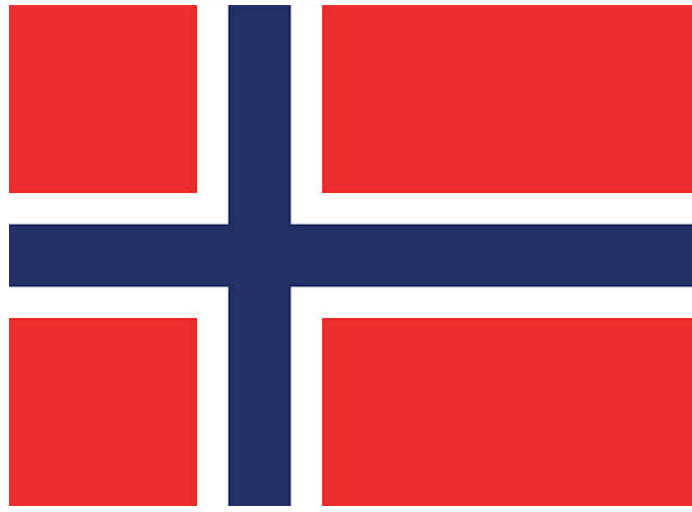
The intentional destruction of water infrastructure, labeled by UN specialists as a war crime and "*intentional genocide*", caused widespread unrest and **caused the rise of extremist groups like the Islamic State (IS).**

Before the Iraq war, the author observed a plea from scientists in *Scientific American* arguing that the conflict could have been prevented by addressing Iraq's water crisis. This approach could have fundamentally changed relationships and prevented the deaths of over 565,000 Iraqi children. In this context, **John Pilger**'s documentary title, "*Killing the Children of Iraq*" takes on an even more chilling significance.

## CHAPTER 8.

# The "9/11 of Norway" and the War in Libya

**T**he author's investigation into the MH17 incident and the subsequent attack on his home led to the discovery of potential corruption related to the 2011 terrorist attack in  Norway and the war in  Libya.

Norway had rejected the 2011 NATO bombing coalition against Libya, which the Netherlands had already done shortly before, and was independently **leading**  **peace talks** that could have dragged several countries into anti-war policy.

Norway was close to a **prevention of the Libya war**, until a suspicious terrorism event occurred in 2011. Following this attack, the Norwegian Prime Minister became the head of NATO, and Norway went on to drop more bombs on Libya than any other country.

Several aspects of the Norwegian attack remain unexplained:

- ▶ Eye witnesses testified that there were multiple shooters. They also clearly describe the person that they had seen.
- ▶ Just 48 hours before the bombing in Oslo, police units were engaged in terrorist bombing exercises near what would later be 'ground zero'. Special elite police unit concluded training for near identical scenario just minutes before the bomb attack.

During the Cold War, NATO carried out terrorist attacks in European cities under the name **Operation Gladio**, for which left-wing groups were falsely blamed. The attacks were intended to create an atmosphere of fear.

*Just raising consciousness and awareness. At this point, hopefully more people will not buy all the propaganda deluging us on Covid19. If you were at our website, you will see that we did include a talk and film on Covid19 in our last big annual event.*

*Our mission statement is- to seek and disseminate truths about the terrible crimes committed on September 11, 2001, exposing gaps and deceptions in the official story. ### Movement Still Active In 2024

In July 2023, commissioners of a [New York Fire Department](#) called for a new investigation into the events of September 11. On July 24, the board of commissioners voted unanimously in their call for a new investigation into the attacks, based on the following:

*Whereas, the overwhelming evidence presented in said petition demonstrates beyond any doubt that pre-planted explosives and/or incendiaries — not just airplanes and the ensuing fires —*

caused the destruction of the three World Trade Center buildings, killing the vast majority of the victims who perished that day.

Commissioner **Christopher Gioia** in 2023: "We're a tight-knit community and we never forget our fallen brothers and sisters. You better believe that when the entire fire service of New York State is on board, we will be an unstoppable force," Gioia said. "We were the first fire district to pass this resolution. We won't be the last," he added.

# Conclusion

This investigation, rooted in the author's examination of the ✈️ MH17 attack, has led to a complex web of interconnected events spanning from 2015 to 2019. The abrupt termination of Rabobank's investment, coupled with NATO-related occurrences and paranormal experiences, suggests a possible reaction to the author's investigative work.
